- 1) As per RTE act. 2009 free and compulsory education for children should be fulfilled
- 2) There is no dispute in the proposed file of society under which the school is.
- 3) The school will follow all the terms and conditions of government secondary school, Maharashtra private school employee rules and act. 1977, Maharashtra private school employee ( service and conditions) act. 1981, compulsory education for children under act of 2009, Maharashtra self finance 2012.
- 4) Society will bound to follow all the rules and regulations and working process under the government resolution date:- 27/05/2013.

5) Presently Primary school has not been permitted separately, It become a part of primary and higher primary school.

6) For appointing Head master, Teacher and non-teaching staff school will take a proper approval from education department from education department.

7) As per government resolution, society should not expect to take any donation at the time of admission.

8) Maharashtra education department (capitation fee prohibition) act.1987 Maharashtra act. 6/88. Date. 15/04/1988. According the society should not take any donation at the time of admission or thereafter and no compulsion for donation from students, parents or employees.

9) School should follow all the terms and conditions of government secondary school Code & Maharashtra private school employee rules and act, 1977 and Maharashtra private school employee (service and condition) rule 1981.

10) The appointment of teaching and non-teaching faculty would be as per government norms and appointment the backward class candidate in proper reservation.

11) As per government rules SANCH MANATYA will be done every year.  
12) School should updates all the accounts and the registers time to time.  
13) The school should have educational environment, concrete building, well equipped library, laboratory and separate room for teachers.

14) As per government order no. PTA/2010/(347/10)/SE - 2/ date. 24/08/2012 a parent teacher association and school management body will be formed, yearly 6 meetings will be conducted and records should be maintained.

15) School should have educational facilities i.e. medical, sanitation for boys and girls as per the number of students, drinking water, play ground etc.  
16) School is expected to collect the tuition fee as per the fee structure sanctioned. For the safety of the students the fire extinguisher is compulsory.

17) School should not change its medium of instruction and the place as mentioned for permission.  
18) The permission of the school will be canceled if it is shifted to some other places without government permission.

19) Maharashtra self finance school (establishment and rules) act, 2012 under this school should not be shifted to anywhere.

20) As per Maharashtra self finance school (establishment and rules) act, 2012 school should be run.

21) As per the government resolution no. 2009/(916/09) dated, 03<sup>rd</sup> Nov, 2009 school should take the certificate of the school building as per the national building code.  
22) Management should pay proper salary, increment and PF. As per private added school and salary should be given through bank.

From the above condition all work should be done.
